1. That I am the attorney assigned to represent the defendant herein, and am fully familiar with the facts and proceedings heretofore had herein.

2. That the above captioned matter charges the defendant with Robbery in the First Degree.

3. That because of extraordinary circumstances, your affirmant was required to exceed the 4,400.00 limit pursuant to 18-b Section 722 of the County Law.

4. That your affirmant has thus far expended eighty-five (85) hours in the defense in the above referenced matter. (Annexed hereto as Exhibit "A" is a list of the hours and work done).

5. That the defendant drafted his own Motions, which became part of an Omnibus Motion package I filed on behalf of the defendant. The case was prepared for trial with the use of investigative services, and included extensive review of video tapes and other items relating to the police identification of the defendant.

6. No previous application has been made for the relief herein requested.

WHEREFORE, it is respectfully requested that an Order be granted permitting your affirmant to exceed the limit of \$4,400.00 pursuant to Article 18-b, Section 722-C of the County Law, and allow your affirmant a maximum of \$6,375.00 for counsel fees, as well as such other and further relief as this Court may deem just and proper.
